Student Lunch Program and Meals Reminder:

- This fall, schools will again begin charging for school meals (breakfast and lunch).
- For about the past two years, due to the impact of the COVID-19 pandemic, school meals have been free of charge for students and families, but this will no longer be the case starting in the fall.
- Although students and families will again have to pay for school lunch and breakfast programs, we have worked with our food service staff to keep costs as low as possible.
- Free and reduced school meal guidelines are still in place and families should plan accordingly if they need to apply for this program.

Families should contact our school office as soon as possible for information on free and reduced school meal guidelines, income parameters, and application procedures.

Beginning of School Information:

- As it stands right now, we are planning to start the **2022-2023** school year as we did prior to the pandemic and that is with no mask requirement at either building. Please note that we will still continue to have safety precautions in place related to lessons learned from the pandemic.
- If students or staff still want to wear masks, that is a decision that they are free to make at their discretion. Although we are planning to start without a mask requirement for staff and students, please be aware that requirement could change if needed based on current health conditions.
- As we did last year, we will continue to follow our local health department protocols as directed throughout the school year. If something changes with the any emerging COVID variants we will adjust quickly and accordingly and communicate these changes to you as soon as possible through our social media channels and district messenger system.

Bennet Elementary uses a school wide positive behavior plan that allows staff to use common language and consistent expectations within the school environment. Behavior Matrix's are posted throughout the school that lists specific expectations for behaviors throughout the school day. BENNET ELEMENTARY OPEN HOUSE:

Bennet Elementary will be hosting an Open House on Wednesday, August 10th from 5:00-6:30 PM. Students/families can meet their classroom teacher, bring school supplies, and take a tour of the school.

BEFORE AND AFTER SCHOOL RECREATION PROGRAM:

Bennet Elementary will continue to offer a before and after school recreation program. Starting on Thursday, August 11th, for a fee, school age children attending Bennet Elementary may take part in this program. There will be a table at Open House on Wednesday, August 10th for you to register your child. If your child will be attending the before or after school care program, please stop by to register your child.

Times: 7:00 - 8:20 a.m. and 3:30 - 5:30 p.m. We

will also offer drop in service for those students that are pre-registered. Students not pre-registered will not be allowed to take part in the program.

Cost: \$2.65/hr per child. Time kept to the

nearest 15 min. increment. A minimum of one hour's time will be charged for

after school participation.

Payment: Prepayment in blocks of \$25.00 or

more. There will also be a \$25 non-refundable registration fee at the begin-

ning of the year.

Supervision: Students will be supervised by at least

one adult. Additional help will be hired if needed so student to supervisor ratio

doesn't exceed 15 to 1.

Structure: Activities will be offered such as board

games, gym games, computer lab time, crafts, and playground fun. Study time and help for those that desire it will be available also. In addition, students will be offered an after school snack and be eligible for school breakfast in the

morning.

The cost of breakfast will be additional.

To parents of school bus route children:

School will be starting on
Thursday, August 11. Your bus
driver will contact you approximately 1 week before school starts
with your pick up time. If you are n

with your pick up time. If you are new to the district and requesting bus service, please contact Cathy Fick 402-540-2879, or email fick.cat@districtor1.net, so that your name can be added to the routes.

The routes and times may not be permanent until we get everyone needing bus service registered. Therefore, times will vary the first week of school, depending on who is riding. You should start to see some consistency starting with the 2nd week of school.

Please note that bus drivers are allowed a maximum of **one minute** wait time during pickups and students to get on the bus, so please have your student ready and waiting outside at their scheduled time.

We ask that if your child will not be riding the bus at any time to please call or text Cathy Fick 402-540-2879. Please make every attempt to call the night before if possible, if not, please call at least 15 minutes before your scheduled pick up time so drivers have time to adjust their route. It is important that the school and driver both have this information. If no call/text was received your child will be picked up and/or dropped off on the normal schedule.

LITTLE PANTHERS PRE-SCHOOL:

Classes for Little Panthers Pre-School will begin on Monday, August 15th. The preschool is for 3 and 4 year old students in the school district. There are four class sessions; two morning sessions will run from 8:00 – 11:30 a.m., along with two afternoon sessions running from 12:00 – 3:30 p.m. Each class session will receive a meal and a snack as part of the program. Please contact Bennet Elementary School at 402–782–3535 for more information.

Please note where there is a late start, school begins at 10:00 a.m. which will make your pick up time approximately one hour and 45 minutes later than normal. Shuttle leave time from Bennet will be 9:30am and shuttle leave time from Palmyra will be 9:45 am.

There is to be no food or drinks on the bus except for plastic bottled water.

If your child has a health issue that you feel the bus driver should be aware of, please let Cathy know.

Please observe parking restrictions and times in the drop off areas at both school buildings. The circle drive restrictions at Bennet are 7:30-8:30am and 2:30-4:15 pm. At Palmyra they are 7:30-8:10am and 3:15-4:00 pm. No vehicles are allowed to enter when buses are stopped to load and unload students.

- Load times at Bennet are 7:35am and 7:45am.
- Load times at PHS are 7:55am and 8:05am
- Load time at the Legion Hall is 7:35am and leave at 7:40am.
- Drop of at Legion Hall is 3:15pm.
- Drop off at PHS is 3:20pm.
- Drop off at Bennet is 3:55pm.

Children need healthy meals to learn. **District OR** 1 offers healthy meals every school day. Breakfast costs \$2.10 at the Elementary, PreK – 5th, \$2.35 at the High School, 6th – 12th; lunch costs \$2.75 at the Elementary, PreK – 5th, \$2.85 at the High School, 6th – 12th. Your children may qualify for free or reduced price meals. Reduced price is \$.30 for breakfast and \$.40 for lunch. If your child(ren) qualified for free or reduced price meals at the end of last school year, you must submit a new application by **Friday**, **September 23**, 2022, in order to avoid an interruption in meal benefits.

This packet includes an application for free or reduced price meal benefits and a set of detailed instructions. Below are some common questions and answers to help you with the application process.

- 1. WHO CAN GET FREE OR REDUCED PRICE MEALS?
 - All children in households receiving benefits from the Supplemental Nutrition Assistance Program (SNAP), Temporary Assistance for Needy Families (TANF) or the Food Distribution Program on Indian Reservations (FDPIR) are eligible for free meals.
 - Foster children that are under the legal responsibility of a foster care agency or court are eligible for free meals.
 - Children participating in their school's Head Start program are eligible for free meals.
 - Children who meet the definition of homeless, runaway, or migrant are eligible for free meals.
 - Children may receive free or reduced price meals if your household's income is within the limits
 on the Federal Income Eligibility Guidelines. Your children may qualify for free or reduced price

- CAN I APPLY ONLINE? No, you can not apply online. You can access the application to print from the district website. www.districtor1.org. 6. MY CHILD'S APPLICATION WAS APPROVED LAST YEAR. DO I NEED TO FILL OUT A NEW ONE? Yes. Your child's application is only good for that school year and for the first few days of this school year. 


